Chair Message, by Rikki Addy

DEAR SHAREHOLDERS & DESCENDANTS,

It was a pleasure to see so many of you at this year's Seattle Shareholders' Informational Meeting in May. It is always an honor to spend time with our Shareholders and Descendants and hear your questions, comments, and life updates while we present updates on your corporation.

We appreciate the time you take to attend The Eyak Corporation's (TEC's) meetings and events each year in Anchorage, Cordova, and Seattle. If you haven't attended a



TEC event in recent years, we hope to visit with you at future events, including the Cordova Shareholders' Informational Meeting July 26th at the Cordova Center, or the Annual Shareholders' Meeting on September 20, 2025 in Anchorage.

As we approach the Annual Meeting, it is a good time to reflect on our rights as Shareholders, including one of the most significant rights we have: voting. Voting your shares allows you to have a say in who sits on the board as well as other important decisions that are brought forth for a vote of the Shareholders. Shareholder participation is vital so that quorum is reached and a valid meeting can be held.

The Board urges you to vote your proxy, even if you plan to attend the meeting in person. Our quorum requirement of more than 50 percent of voting shares is much more challenging to reach than a reduced quorum requirement. However, we believe the increased Shareholder participation associated with the higher quorum requirement is well worth the additional effort it takes to reach that threshold.

In service of ensuring we reach a quorum at this year's meeting, TEC is introducing an online voting platform. This platform will allow Shareholders to electronically submit their votes for the Board. TEC will also continue to mail Shareholders paper ballots. We are confident these efforts will make it easier for Shareholders to vote and for the corporation to reach quorum.

As additional motivation to encourage proxy voting, the Board of Directors approved the proxy incentive program in 2012. Shareholders who submit proxies to the corporation by September 19 have the option to receive \$50 or donate the \$50 proxy payment to The Eyak Foundation. There will also be early bird prizes. The only way to be eligible to win a prize is by submitting a proxy by the specified deadline.

Thank you for showing enthusiasm and interest in your corporation. We look forward to seeing you at the remaining in-person gatherings we have planned for the remainder of 2025. Wishing you and your loved ones a safe and enjoyable summer!

Seattle Shareholder Informational Meeting Recap



The Eyak Corporation (TEC) held a Shareholder Informational Meeting on Saturday, May 3 at the Seattle Hilton Airport and Convention Center in Seattle, Washington. We greatly appreciate all those who made time to attend the Seattle Shareholder Informational Meeting.

During the meeting, CEO Thomas Mack provided a Management Report and Chief Financial Officer Sue Jolin followed with a financial update. Board members gave several brief committee updates on the Donations, Shareholder Advisory, and Land Committees, as well as an update on The Eyak Foundation. Additionally, some of our Shareholder Advisory Committee Members provided introductions.

TEC provided an early lunch for the attendees, giving Board Members, Shareholders, Descendants, and Staff time to visit with one another. These discussions are always a highlight of our Shareholder Informational Meetings.

During this meeting, a silent auction was held to benefit The Eyak Foundation. The silent auction raised \$1,121.00, which was doubled by TEC's Board of Directors match for a total of \$2242.00. These funds will benefit The Eyak Foundation's scholarship program, benefiting our Shareholders and Descendants by helping to ease the financial burden of higher education.

TEC Working on NOAA Fish Passage Project on Copper River Delta



This past year TEC has been busy working with local business partners and non-profits on fish passage on the Copper River Delta. Last summer TEC was able to successfully replace three culverts in two different locations. One of the locations was on Cabin Lakes Road and the other was at mile 15 that crossed the Copper River Highway. These culverts will allow fish to continue to swim upstream and spawn for future generations of fish and subsistence. Copper River Watershed Project continues to be a big partner in this project and have TEC lands and culture at the front on these developments and discussions. We look forward to finishing up this NOAA Fish Passage Project summer of 2026 and look forward to maintaining the work of fish passage and land stewardship.



How to Enroll in the Native Village of Eyak

The Eyak Corporation has recently received several inquiries regarding enrollment in the Native Village of Eyak. Though The Eyak Corporation and the Native Village of Eyak often work closely with one another, we are two separate entities. The Eyak Corporation (TEC) is an Alaska Native Corporation created pursuant to the Alaska Native Claims Settlement Act of 1971. TEC seeks to represent and benefit its Shareholders through contracting opportunities, distributions, and the management of land and resources. The Native Village of Eyak (NVE) is a federally recognized Tribal government which represents and supports its Tribal Members primarily through health and social services, economic development, natural resource/environmental education, job opportunities and training, as well as cultural services.

To become a Shareholder of TEC, one must either inherit or be gifted shares. To enroll as a Tribal Member with NVE, one must submit an enrollment application along with their Certificate of Degree of Indian Blood, birth certificate, and two proof of residency documents. For those who are descendants of the Native Village of Eyak, you may still enroll if you do not live in the NVE traditional boundaries, but as an Inactive Tribal Member, who is still eligible for a Tribal ID Card, but not eligible for NVE services or voting.

The Eyak Corporation's (TEC) 51st Annual Shareholders meeting will be held in Anchorage, Alaska on Saturday, September 20, 2025. TEC will send out the Solicitation for Candidates via mail to all Shareholders. The purpose of this mailing is to solicit qualified candidates to run for the three seats on TEC's Board of Directors currently held by Rikki Addy, Ashley Christensen, and Matthew Andersen.

Shareholders wishing to run for the Board will be instructed to submit a completed Candidate Application Form, including all required attachments, to be published in TEC's Proxy Statement ahead of the Annual Meeting.

To qualify to serve on TEC's Board, you must:

- Be a holder of voting stock of The Eyak Corporation;
- Be at least 18 years of age;
- Agree to and execute the Code of Conduct Policy;
- Agree to and execute the Confidentiality Policy;
- Not serve on the board of directors or as an officer of another corporation organized under the Alaska Native Claims Settlement Act;
- Not serve on the board of directors or as an officer of a non-Corporation owned entity that is participating in the Small Business Administration's 8(a) Business Development Program.

Did you know that skin cancer is America's most common cancer? May was Skin Cancer Awareness month. Approximately 9,500 people in the U.S. are diagnosed with skin cancer daily. There are several types of skin cancer which include basal and squamous cell carcinomas and melanoma. These are the types you hear about most often. Some people are at a higher risk of skin cancer, but anyone can get it.

Skin cancer symptoms vary from person to person. It can be a change in a mole or birthmark, a new growth, or a sore that doesn't heal. It is important to check your skin regularly. Too much exposure to ultraviolet (UV) rays, either from the sun, tanning beds, or sunlamps increases your risk.

It is important to use broad spectrum sunscreen during long periods of sun exposure or cover exposed skin with clothing like hats or long-sleeved shirts and pants. The experts recommend sunscreen of SPF 15 or higher and to make sure that you reapply if you are out for long periods of time or in the water. When planning outdoor activities, try to find areas that can provide shade like gazebos, covered picnic areas, or places with large trees.

We all love a nice sunny day whether it be family activities at the park or a beautiful day out on the water. Make sure you pack your SPF 15 or higher sunscreen, protective clothing, and an umbrella for shade and start enjoying the nice days ahead.

We are in the final stages of research, development, and compliance with the expectation to have it rolled out later this year. Controller Bay, LLC Awarded New \$10M DoD Neurocognitive Testing Contract



The Eyak Corporation is pleased to announce that on June 2, 2025, Controller Bay, LLC was awarded a one year, \$10M contract by the U.S. Army Medical Command (MEDCOM) to support the Department of Defense's (DoD) Neurocognitive Assessment Program (NCAP). This contract positions Controller Bay as the Contract Service Provider (CSP) to deliver neurocognitive assessment and support services across all DoD agencies, including the Army, Navy/Marine Corps, Air Force, and Space Force, with potential future expansion to the U.S. Coast Guard.

The contract focuses on providing baseline and reassessment neuropsychological testing for military Service Members (SM), new accessions at Initial Military Training (IMT) sites, and DoD civilian employees in at-risk occupations or locations. Controller Bay will also support neurocognitive assessments for SMs who have sustained head injuries, experienced potentially concussive events, or exhibit symptoms indicating possible brain injury or exposure to hazards such as blast overpressure, directed energy weapons, or toxins.

As part of the contract, Controller Bay will deliver comprehensive program support, including laptop configuration for the Automated Neuropsychological Assessment Metrics (ANAM) or other designated Neurocognitive Assessment Tools (NCAT), customer and technical support, IT support, data management, and administration of computer-based neurocognitive testing. Controller Bay will sustain a strategically positioned nationwide network of contract-staffed NCAT testing sites at premier military installations, including the U.S. Military Academy at West Point, the U.S. Naval Academy, the U.S. Air Force Academy, Great Lakes Recruit Training Command (IL), Lackland Air Force Base (TX), Fort Jackson (SC), and Fort Sill (OK). The contract effort aligns with key DoD directives, including DoD Instruction 6490.13, the Warfighter Brain Health Initiative, and the Deputy Secretary of Defense's memo on managing brain health risks. Controller Bay's work will support the DoD's goal of completing baseline cognitive assessments for all Service Members by FY2027, with ongoing reassessments throughout their careers.

This contract underscores Controller Bay's unwavering commitment to advancing and safeguarding the cognitive health of the Department of Defense's Service Members and civilian workforce through comprehensive assessment efforts at locations worldwide. We are honored to contribute to the NCAP's critical efforts to provide baseline and follow-up neurocognitive assessments, ensuring the readiness and well-being of those who serve.


