Frequently Asked Questions

Q. How many Shareholders originally enrolled into TEC, how many of them are still living, and how many total Shareholders does TEC have?

A. TEC had 326 original enrollees. Almost half of the original enrollees (161) are still living. As of September 30, TEC has 643 Shareholders.

Q. Why did TEC's Cordova Shareholder Informational Meeting start at 9 am?

A. The dates and start times of our Shareholder meetings are based on feedback from Shareholders as well as efforts to keep costs down. For example, as requested by Shareholders we stopped scheduling the Cordova Shareholder Informational Meeting during Sobriety Celebration. We also moved the Annual Shareholders' Meeting date from May to September at the request of Shareholders.



A. TEC is entitled to an additional 6,505 acres of land. The Bureau of Land Management has informed TEC that a "legislative fix" is needed for TEC to receive our full entitlement of ANCSA lands.



Q. Does TEC offer Veteran benefits?

A. TEC does not offer any specific Veteran benefits, at this time. TEC has recognized Veterans through several avenues, including: Veteran spotlights in the Shareholder newsletter; certificates of appreciation to Veteran Shareholders; and spearheaded the Veterans monument in Cordova.

Q. Why is it important for Shareholders to cash distributions from the Eyak Permanent Fund Settlement Trust within one-year of issue?

A. The Eyak Permanent Settlement Trust provides that any distributions not claimed within 365 days from the date of distribution are forfeited and added to the Trust Principal.

Q. How much money does The Eyak Foundation have?

A. As of September 30, The Eyak Foundation has total assets of \$4.1 million.


